NOTICE OF PROPERTY TAX INCREASE

The Town of Brooks has tentatively adopted a 2022 millage rate which will require an increase in property taxes. The Net Taxes % increase is 34.71%. (To calculate the % increase use the following formula: If rollback is greater than zero, take the 2022 millage rate of 1.207, subtract rollback millage rate of 0.896, use the answer to divide rollback millage amount equates to the percentage of Net Taxes % Increase.

Calculation:

Rollback Millage Rate: 0.896 Proposed Millage Rate: 1.207

1.207-0.896 = 0.311 0.311 / 0.896 = 34.71%

All concerned citizens are invited to the public hearing on this tax increase to be held at Town Hall, 961 Highway 85 Connector, Brooks, GA on August 29, 2022, at 6:30 p.m.

The tentative increase will result in a millage rate of 1.207 mills, an increase of 0.207 mills. Without this tentative tax increase, the millage rate will be no more than 1.0 mills. The proposed municipal tax on a home with a fair market value of \$300,000 is approximately \$144.84 a year.
